



## COVID-19 STATE OF EMERGENCY GUIDELINE

Effective April 16, 2020 the following will be in effect for the Santa Rosa Reservation Tribal Members and Residents.

1. Per Resolution 04162020 issued by Tribal Council ordering all persons living within the Santa Rosa Reservation to Stay at Home at their place of residence, practice social distancing, limiting visitors to the reservation with the exception of immediate family members or those providing essential services.
2. Essential Personnel is that of: Tribal Council, Tribal Administration, Health Care Providers, childcare providers, and emergency services.
3. "Social Distancing" is maintaining a six-foot distance from all persons except for household members.
4. Limiting all travel off the reservation to only travel for essential services such as: necessary shopping for food, fuel stations, school nutrition programs, day care and childcare, doctor appointments.
5. We strongly recommend designating one family member to leave the reservation for all essential shopping.
6. All Tribal Members, Visitors, and Essential Workers shall wear face coverings such as: masks, scarves, bandanas, neck gaiters, or other fabric face coverings.
7. The Tribal Hall will remain closed until further notice, social gatherings and or activities of max 50 people are allowed outdoor in the park area behind the Tribal Hall with prior authorization from Tribal Council. It has been a consensus of General Council to reopen the parks and basketball courts.
8. A strong recommendation is made that all persons who are 65 years old or older, have a chronic underlying condition or have a compromised immune system self-quarantine themselves at home.
9. All persons traveling to the reservation from another state will be asked to self-quarantine at home for 14 days.
10. A strong recommendation is made for any persons exhibiting mild to moderate symptoms of COVID-19 to self-isolate themselves in their place of residence unless seeking medical treatment along with notify Tribal Administration.
11. The loop can be utilized for exercise. All minors under the age of 13 must be accompanied by an adult over the age of 18.



12. All drivers please adhere to the reservation speed limits and stop signs to make it safe for pedestrians who may be exercising.
13. Please wash or sanitize your hands and attempt to avoid touching your face to reduce the spread of disease.
14. The Tribal Administration is currently temporarily closed to the public and may be closed from time to time due to COVID-19 precautions. Contact the front office to make appointments and arrange pick up of tribal documents prior coming to the Tribal Office.
15. All forms have been posted on the website. You may request to receive or drop off forms by mail, fax, email or in person.
16. Tribal Council and Tribal Administration shall enforce social distancing requirements at all parks, tribal hall, basketball courts and other social gathering areas.

These guidelines are effective immediately and will remain in effect until pending further order of the Public Health Officer and or conditions are deemed safe assessed by Tribal Council.

These guidelines are being issued as a result of the pandemic of COVID-19 virus. We are implementing these guidelines to reduce the exposure of COVID-19 therefore slowing the likelihood of the spread of COVID-19 within the reservation.

Please adhere to such guidelines as set forth by Tribal Council.
